Guidance

For applications for inclusion in the electoral register for European Parliament elections in Denmark by EU citizens living in Denmark¹

1. The conditions for voting in the election

If you are an EU citizen with permanent residence in Denmark and you have reached the age of 18 on election day at the latest, you have the right to vote for the European Parliament in Denmark.

You have permanent residence in Denmark if you are registered in the Central Personal Register (CPR).

However, aliens who have been deported by final judgment or decision (according to sections 22-24 or 25-25 c of the Danish Aliens Act) do not have the right to vote.

2. You must apply to be included in the electoral register in order to vote in the election

In order to vote in the election, you must be registered in the electoral register. If you are an EU citizen living in Denmark, you can only be included in the electoral register for elections in Denmark if you apply for it (using this application form). This is because EU citizens living in a Member State other than their home country can choose whether to vote in the elections in their home country or in their country of residence. However, you can only vote in one place, so you are not allowed to vote in both Denmark and your home country.

If you wish to vote in the Danish election, you must fill in the application form and send the application to the municipality where you live.

If you were in the electoral register in Denmark at the last European Parliament election, you do not need to apply to be in the electoral register for the upcoming European Parliament election, unless you have moved abroad, to the Faroe Islands or Greenland in the intervening period or have asked to be struck off the electoral register. See clauses 5 and 6.

3. Application deadline

The municipality must receive your application no later than five weeks before election day for it to take effect for the election. The deadline is moved to the next business day if it falls on a Saturday, Sunday or public holiday. For the European Parliament elections on 9 June 2024, the deadline is **Monday 6 May 2024**.

Instead, the deadline is four weeks before election day (**Monday 13 May 2024**)* if, in the period from six weeks before election day (29 April 2024)* up to and including five weeks before election day (6 May 2024)* you either:

- 1) have moved to Denmark,
- 2) have notified your new municipality of your move, or
- 3) have become a citizen of one of the other EU countries.

*Deadlines are moved to the next business day if they fall on a Saturday, Sunday or public holiday. The dates in brackets are the deadlines for the European Parliament elections on 9 June 2024.

Applications submitted after the above deadlines will not take effect for the next European elections (9 June 2024), but may take effect for the next elections (in 2029). This application form can therefore also be used after the European Parliament elections on 9 June 2024 have been held.

4. Processing of the application by the municipality

The application is processed and decided by the municipality where you live. If you are missing any information on the application form or if the information does not match the information in the Central Personal Register (CPR), the municipality will notify you and ask for more information.

5. If your application is successful

If your application for inclusion in the electoral register is approved, you will be included on the electoral register for European Parliament elections in Denmark for as long as you live in Denmark. Therefore, you do not need to apply to be in the electoral register for the next European Parliament elections, as you will be automatically included in the electoral register. However, if you move abroad, to the Faroe Islands or Greenland or ask to be struck off the electoral register, you will need to reapply to be added to the electoral register.

6. Deletion from the electoral register

You can always ask the municipality where you live to be struck off the electoral register. The municipality must receive your request no later than 15 days before election day for it to take effect for the election. The deadline is moved to the previous business day if it falls on a Saturday, Sunday or public holiday. For the European Parliament elections on 9 June 2024, the deadline is Friday 24 May 2024.

7. Processing of personal data

Under the General Data Protection Regulation and the Danish Data Protection Act, you have the right to access the data that is registered about you. You can contact the authority that registers the data (the municipality). You can demand that any incorrect information registered about you be rectified.
